## 1. GENERAL INFORMATION FOR WILLINGEN

### a) Arrival in Germany

- Travellers who have visited a high-risk area or area of variant of concern in the last ten days must register at [www.einreiseanmeldung.de](http://www.einreiseanmeldung.de) before arriving in Germany and carry proof of registration with them upon entry. Exemptions to this registration requirement apply in particular to persons who
  - have only passed through a high-risk area or area of variant of concern without a stopover,
  - are only passing through Germany, or
  - in the case of border traffic: persons who have spent less than 24 hours in a high-risk area or area of variant of concern or are only entering Germany for a period of up to 24 hours.
- Upon entering Germany, travellers aged twelve years or older must hold proof of the following:
  - Entry from an area of variant of concern: negative COVID-19 test result (PCR not older than 72h or antigen test not older than 24 h). Proof of a full COVID-19 vaccination or proof of recovery from an infection is not sufficient.
  - Entry from high risk area: a negative COVID-19 test result (PCR not older than 72h or antigen test not older than 48 h), proof of a full COVID-19 vaccination or proof of recovery from an infection (not older than 6 months).

This proof must be held prior to entering the country and must be presented to the airline before departure where applicable.
- Proof of vaccination against COVID-19 in German, English, French, Italian or Spanish in digital or paper form (e.g. EU Digital COVID certificate; WHO vaccination booklet). Note that a photo of a proof in paper form is not sufficient. Also the vaccine used must be one of those listed on the website of the Paul-Ehrlich-Institut (BioNTech/ Pfizer, Astra Zeneca, Johnson& Johnson, Moderna)

## b) Covid-19 Test Procedure

### - THE FOLLOWING VACCINATIONS ARE CURRENTLY VALID FOR EVENTS IN GERMANY:

- BioNtech/ Pfizer
- AstraZeneca
- Moderna
- Janssen Pharmaceutica NV (Johnson & Johnson) (only with a 2nd vaccination!)

### **PLEASE NOTE THAT IF YOU ARE VACCINATED WITH ANY OTHER VACCINE THIS WILL BE SEEN AS UNVACCINATED!**

In general the following test scenario will take place for the World Cup in Willingen:

Quick test red group on arrival in Willingen (27.01.2022)

The first test will be performed by the LOC Willingen. A negative PCR test result to be uploaded to the FIS passport. Otherwise your accreditation is invalid and you have no access to the venue.

### **PLEASE NOTE: ALL PERSONS OF THE "RED GROUP" MUST SHOW A NEGATIVE PCR TEST RESULT EVEN IF VACCINATED OR RECOVERED.**

- This test must be carried out in the test center maximum 48-24 hours (time of testing is relevant, not time of the result) before entering the event venue for the first time on January 28. This time limit must be considered when making travel plans.

- The testing centers for the event in Willingen are located directly in the stadium at Mühlenkopfschanze 1, 34508 Willingen - Ausgang VIP 1st floor. You must bring your identity card/ passport with you.

The opening hours still need to be confirmed.

c) *Accreditation/ Race Office*

- For the World Cup in Willingen, each team must register on Ski-Network and follow the instructions on the platform to apply for accreditations

- Activation of the accreditation

Please note: A printed accreditation alone is not sufficient and does not entitle the holder to access the event. The accreditation will only be activated when the vaccination proof has been uploaded and "red bubble" users have uploaded their negative PCR test (+/- 48h) into the FIS system!

**IMPORTANT**

**THE ACCREDITATION PLATFORM SKI-NETWORK HAS NO CONNECTION TO THE FIS ENTRY SYSTEM. PLEASE MAKE SURE TO ORDER YOUR ACCREDITATION THROUGH THE SKI-NETWORK PLATFORM.**

**AN ADDITIONAL REGISTRATION ON THE SKI-NETWORK IS MANDATORY TO GET ACCREDITATIONS FOR THE WORLD CUP IN WILLINGEN.**

**ACCESS TO THE TEST CENTER IS ONLY POSSIBLE WITH AN APPLIED ACCREDITATION.**

**IT IS RECOMMENDED THAT ONLY ONE TEAM-MEMBER GATHERS ALL ACCREDITATIONS FOR THE WHOLE TEAM.**

- PLEASE NOTE: There will be no guest accreditations offered this season!

#### d) Accommodation

- Official regulations for hotels are that only vaccinated or recovered persons with a valid EU certificate are accepted (German 2G).
- For professional stays there is an exception that instead of vaccination a valid PCR test not older than 48h can be accepted (German 3G+), however hotels are not obliged to accept 3G+ and might only accept 2G
- If you don't have a valid EU certificate of vaccination or recovery, please contact your hotel to check on their regulations!
- Every team member is obliged to stay in their designated hotel for the duration of the event.
- Wear an FFP2 mask in all public areas.
- In the buffet area a face mask is also obligatory but can be put down at the table.
- Further hygiene measures are presented in the hotel.
- Recommended use of stairs instead of lift.
- All hotels follow the regulations of the German Health Department

#### e) Transportation from hotel to venue

- Team shuttles can be ordered according to past years.
- Cars can be ordered.
- Shuttle drivers are tested negative for COVID-19 and wear an FFP2 mask.
- Wearing an FFP2 face mask without a valve during transport is mandatory.
- Avoid stopovers between lodging and venue.

#### f) Regulations at the venue

- The participants at the World Cup in Willingen are divided into different groups and areas/ bubbles (red: teams, blue: staff and orange: media). These areas are clearly marked at the venue.
- Avoid contact with persons of the other bubbles (blue or spectators)
- But also avoid contact with other teams.
- Always keep social distance!
- **FFP2 face masks are mandatory in the entire event area!** Excluded:
  - During the sports exercises.
  - During the warm-up and directly before the start after the equipment control.
  - During meals.
- Please sit in the athlete village with team members only.
- Masks are mandatory in all lifts. The capacity of all lifts is limited and will be displayed at the entrance of the lift.
- As last year, wearing an FFP2 mask is mandatory in the team hospitality area. It will be allowed to stay there to warm up. We will offer sandwiches, soup, candy, cereals and bottled beverages.

#### *g) Mixed Zone/ Media*

- Since the distance of 1.5 m in the mixed zone cannot always be maintained, the wearing of FFP2 masks for all persons in the mixed zone (media representatives, athletes, FIS staff, ...) is mandatory.
- Compliance with these rules will be monitored by representatives of the organizer/ security service.
- Gatherings of athletes in the aisles are to be avoided under all circumstances.
- Detailed information for media representatives will follow.

#### *h) Coaches' Platform*

Access to the platform only for coaches with FFP2 masks.

#### *i) Warm-up Room/ Start*

Access only for athletes. Wearing an FFP2 mask is mandatory in the warm-up room in Willingen. The number of people in the warm-up room is limited.

Immediately before the start the mask can be taken off.

#### *j) Team Captains' Meeting (TCM)*

The TCM for Willingen will take place on January 27, 2022 at 6:00 p.m. at the Gutshof Itterbach, 1st floor. Directly after the TCM the TV briefing will take place. Please note that only one team member per nation is admitted to the TCM.

#### *k) Doping Control*

In case of possible doping controls, all participants have to wear FFP2 masks the whole time.

#### *l) Covid-19 Communication/ Contacts*

- In the event of a positive test result, the following rules of conduct must be followed:
  - Self-isolation,
  - The hygiene team and LOC hygiene staff will be informed,
  - The local health authorities will be informed,
  - Further action will be coordinated by local health authorities.

## **2. MISCELLANEOUS**

Due to the pandemic, we as organizers are forced to limit the number of accredited persons.

Therefore, only team officials within the FIS contingent have access to the team and sports areas.

### **No guest accreditations.**

We appeal to everyone's personal responsibility and compliance with all necessary measures and regulations! There will be stewards to enforce and control strict compliance with all rules.

Please follow the instructions of the stewards in the interest of your own safety and the safety of other participants.

In case of violations of COVID-19 rules, the LOC reserves the right to exclude people from the event and take legal action if necessary.

Please note that all information is as of early December 2021. Due to the dynamic situation, it is very likely that changes may occur at short notice. Of course, we will notify you at any time if there are relevant changes that may affect your planning or participation.
